Participant Agreement, Release and Acknowledgement of Risk

I acknowledge that my child will be participating in the 2019 Thomas D. Horne Leadership in the Law Camp ("Law Camp"). The Law Camp is sponsored by the Loudoun Bar Foundation. In consideration of the services provided by their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their own behalf (hereinafter collectively referred to as "Law Camp Affiliates") for the Law Camp, I hereby agree to release and discharge Law Camp, Law Camp Affiliates, and the Loudoun Bar Foundation on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in Law Camp's activities including but not limited to: conferences, meetings, travel to meeting sites, dancing, recreation, sports, hiking, challenge course and team building programs and river rafting, entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. **In addition to the risks already stated, other risks include but are not limited to:** During an activity, there may be contact with plants, animals, or insects that could create hazards such as stings, allergies, and associated disease. While we make every effort to ensure food allergens are not present, the caterer or restaurant may prepare foods at their facilities containing nuts, gluten, shellfish, and/or other foods. Furthermore, Law Camp Affiliates have difficult jobs to perform. While they are concerned with safety of participants, they may not be aware of participant fitness or ability, and not be able to accurately judge all weather conditions.

2. I expressly agree and promise to accept and assume all risks existing in the activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and to hold harmless Law Camp from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Law Camp's or Foxcroft's equipment or facilities, including any such Claims which allege negligent acts or omissions by Law Camp.

4. Should Law Camp, the Loudoun Bar Foundation, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created directly or indirectly, by any such condition.

6. I understand and agree that Virginia Law shall govern this agreement.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Law Camp, any Law Camp Affiliates, or the Loudoun Bar Foundation on the basis of any claim from which I have released them herein.
